EVENT LOCATION & TABLE SETUP

The Law School Fair will be held in Exhibit Hall 111 on the first floor of the Wes Watkins Center for International Trade at Oklahoma State University, 810 W Hall of Fame Ave, Stillwater, OK 74078. Representatives may arrive anytime after 8:30 a.m. Each participating school will be provided one 8-foot table and two chairs.

PARKING, ARRIVAL & UNLOADING

Complimentary parking will be provided for participating law schools and representatives in Lots 9 and 9A immediately outside the Wes Watkins Center. Please enter from N. Washington Street. The first 40 schools/vendors to arrive will receive priority reserved parking in Lot 9A; all others will be directed to Lot 9, a staff parking lot. Please note that the Lot 9A entrance from Hall of Fame Avenue will be closed.

If you need to unload materials on the morning of the fair, please use the circle drive on the east side of the Wes Watkins Center before proceeding to your assigned parking area.

TRAVEL TO STILLWATER

Stillwater Regional Airport (SWO) is the recommended and most convenient airport for visitors traveling by air, with the terminal located only a short drive from the OSU campus. Representatives may also consider OKC Will Rogers International Airport (OKC) in Oklahoma City or Tulsa International Airport (TUL). Both are approximately 70 miles from Stillwater, so travelers using either airport should plan for roughly 75-90 minutes of driving time, depending on traffic and conditions.

ACCOMMODATIONS & FOOTBALL WEEKEND

No hotel block has been reserved for the Law School Fair. Convenient options near campus include Best Western Plus Cimarron Hotel & Suites, Home2 Suites by Hilton, Fairfield by Marriott, and Hampton Inn & Suites, particularly properties along Hall of Fame Avenue. Oklahoma State University also operates The Atherton Hotel, a historic boutique hotel located on campus.
